Clairmont Elementary School has developed a written Title I parental involvement policy with input from Title I parents. Clairmont convenes an annual meeting to inform parents of Title I students of Title I requirements and their right to be involved in the Title I program.

During the first quarter of the school year, an evening meeting is held by the Principal and other staff members to inform parents about Title I requirements and parental involvement. Feedback from parents was received at the English Language Advisory Committee and School Site Council meetings. Parent survey results also provide additional input. The policy will be distributed to staff and parents via Blackboard communication, hard copies sent home and also on the school website for reference.

Each August the annual meeting is held and parents are given Title I information at this time.

Clairmont will hold meetings both virtually and in person at varying times of the day. A flexible number of meetings will be held to accommodate all stakeholders.

Student progress in relation to state and local standards will be explained to parents including the curriculum being used, grade-level expectations for proficiency, data reporting for state and local assessments and available interventions in ELA and mathematics for students needing assistance.
