\* Information is shared through ClassDojo which provides parents the ability to translate into their home language.

- \* Enforce rules equitably and involve students in creating a warm and caring learning environment.

Davis Elementary Staff are available to parents through email and phone calls. In a traditional year, parents are invited to volunteer in classrooms and on field trips, as well as observe classroom activities and attend assemblies and evening events.
