# **Superintendent's Report**

Superintendent Young expressed thanks to the staff, families, and community of Lakewood Elementary School for persevering through the first month of school while the new parking lot was being completed. He spoke about visiting Sutherland, Podesta Ranch, Oakwood, and John Muir school sites, stating there are wonderful things happening but was also reminded of the challenges that our school sites face. He thanked Selene Wang, Student Board Representative, Middle College High School, for the opportunity to join the Student Government Meeting at Middle College. Mr. Young stated that Ed Services is finishing up gathering feedback from parents,

staff, and students on cell phone use during school and that a report will be presented at the next Board meeting.

# **Comments from Employee Representatives**

Rodrigo Contreras, President, California School Employees Association (CSEA), Lodi Chapter #77, introduced himself as the new CSEA President of Lodi Chapter #77.

Lisa Lennon-Wilkins, President, Lodi Education Association (LEA), stated that she hopes the district and LEA can settle before the end of the school year. She spoke about complaints she has been receiving about facilities issues, such as, new flooring getting installed in only half a school and the need for pest control services. Mrs. Wilkins voiced her concern with combo classes and class sizes.

### **Comments from the Public**

Maricela Sandoval Espinoza, Library Media Assistant, Tokay High School, thanked Mr. Stroh and Mr. Young for visiting the school site and requested a meeting with all library media assistants, Mr. Young and Mrs. Gabby Vazquez, Instructional Media Services, Supervisor, to better collaborate and find a solution.

Kelly Hansston, Teacher, Julia Morgan Elementary, spoke about realtors not using Lodi USD as a selling point anymore and her hope that the district will start to show respect to the teachers.

Amy Conyers, Library Media Assistant, spoke about Mr. Young visiting her school site. She stated she does not feel respected and would like a meeting to be held with all library media assistants to discuss how to fairly compensate with the additional requirements of the job.

Sherry Kelly, Library Media Assistant, spoke about wanting a meeting with all library media assistants, not just a surprise site visit from Mr. Young. She stated she would like a new job description, with compensation to reflect.

Mary Hooley, Community Member, voiced her concern about sexually explicit books being available to students in school site libraries. She handed out a packet highlighting the books in question.
